

## Agenda:



5. Any other:

  - c) To coordinate research, teaching extension and other Academic activities.

## Resolutions:-

Board of studies in Pharmaceutics discussed the Proposed agenda and made the following resolutions to be implemented for I/IV and II/IV B. Pharmacy / I/II M. Pharmacy Pharmaceutics and Industrial Pharmacy Courses (1st and 2nd Semester) from the academic year 2017-18.

1. It is resolved to approve Syllabus, academic regulations, Scheme of instructions, Scheme of examinations, Question paper pattern (Semester end and Sessional) for various subjects related to M. Pharmacy Pharmaceutics and Industrial Pharmacy as per the PCI norms to be implemented from the academic year 2017-18.  
(Enclosed copy of Syllabus). M. Pharmacy (MPH&MP) programs are enriched with 5-8 additional laboratory practicals.
2. It is resolved to approve Syllabus, academic regulations, Scheme of instructions, Scheme of examinations, Question Paper pattern (Semester end and Sessional) for various subjects related to Pharmaceutics of B. Pharmacy course as per PCI norms to be implemented from the academic year 2017-18 (Enclosed copy).
