RESOLUTIONS OF 10TH GOVERNING BODY to CLPT

I am honored to present a comprehensive report on the achievements of Chalapathi Institute of Pharmaceutical Sciences from January 1, 2023, to September 30, 2023. Our institution achieved an impressive NIRF (National Institutional Ranking Framework) rank of 89. A total of 32 research papers were published during this period, with 27 papers indexed in reputed journals. Additionally, our faculty published 3 books, 2 book chapters and Students published 2 book chapters. In our pursuit of fostering cutting-edge research, we acquired advanced equipment, including Hot Melt Extruder, Spheronizer, Biochemical Analyzer, and Digital Transdermal Film Former. We conducted a total of 18 guest lectures, 4 skill development courses, 3 seminars and 13 workshops/hands-on training activities. These sessions enriched the learning experience of our students and faculty. We generated Rs.2,13,800 through sponsored research, Rs 24,800 through consultancy services, and Rs 37,500 through corporate training initiatives. Our 19th Annual Day celebrations, held on March 30, 2023, were a grand success. During this event, we recognized and rewarded the commitment of students with 100 percent attendance by distributing merit scholarships and prizes. IQAC submitted 2021-2022 AQAR report on 31/06/2023. 11th Academic council and 33rd research and development cell meeting was organized on 11/08/2023 and 09/06/2023 respectively.

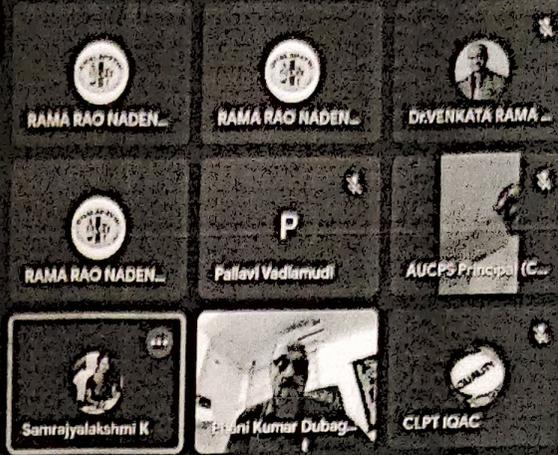
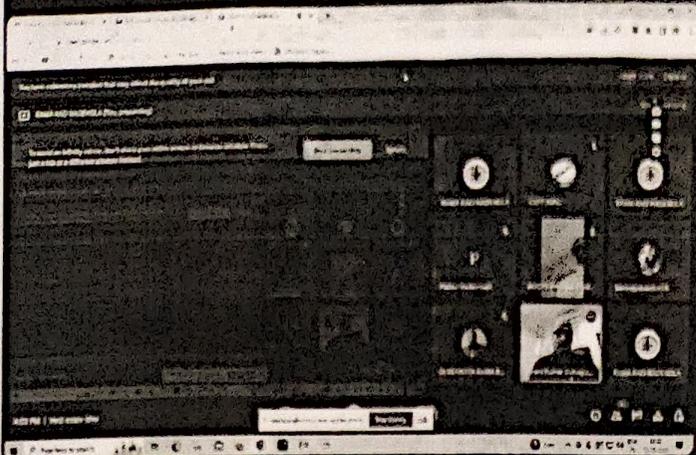
2. 10th GB also considered and approved all 06 resolutions of 11th academic council meeting:
